Rosemarie Demmons reminded owners to pick up their new fobs.

Hal Spector gave us his Treasurer's Report as follows:

Cash - Operating Fund = \$1,886,994

Cash - Reserves Plex = \$1,204,643

SFH = \$1,243,124

Total Reserves = \$2,447,767

Micki Gaughan: (1) Reminded us of the Bill Kling VA Complex food drive that we are having. There is a bin in the lobby of the main clubhouse. We will be collecting non-perishable, non-expired food items until Memorial Day. (2) On Saturday a gentleman was soliciting in the area. He was told to leave. Do not open your doors to strangers. (3) Dead Bug Edwards is collecting broken bait boxes. Every box is marked and filled every other month. There are some 113 missing and broken boxes. People are apparently throwing them out or moving them. Do not do that. First of all, they are filled with poison and should not be touched and, secondly, they have been placed in appropriate places by Dead Bug Edwards where they will perform best. In order to replace these boxes it will cost \$2,486.00. Arline Marcus asked if Micki had addresses where they were missing or moved and suggested we send out a letter to these people. Barbara Bucci said that we have removed many banana trees which the rats nest in. They also like the arrica palms and papaya, which they eat. Kristi Woods said that she heard that people believe that the holes in the ground were made by rats. They are made by our burrowing owls. Please let us know if you find holes and we will alert Doug to mark them.

<u>Barbara Bucci</u>: said that we are going to have a truckload of soil delivered to put around the community where debris from the hurricane was or where trees were removed.

Arline Marcus: Do not leave your doors unlocked. This means car doors as well.

<u>Joanne Hill</u>: Do not put your outgoing mail in your mailbox. We have had people taking the mail. Put it in the mailbox at the main clubhouse. Sam Normandia said there are several mailboxes at the Bank of America building at the end of 17<sup>th</sup> Street on Pine Island Road.

Hal Spector: It is worth repeating: Get your amendment ballots/proxies in and pick up your fobs.

GOOD AND WELFARE: Harriet Langdon asked if a patio being constructed near her was made of polywood? Sam Normandia told her yes it was. She also said that notices for the professional shows were not on Lauderdalewest.org and spoke about the ad in the Sharp Saver. She and Sandy Spector also asked if the ticket office may sell tickets for two shows. Sandy is having a meeting next week with her committee and she will get back to us.

Marion Hinton asked about plex roofs and hurricane season. Joanne Hill said that she signed roofing permits for 20 plexes and SCI will begin shortly.

Theo Susser also asked about the plex roofs. Joanne told him that we are negotiating with the insurance company.
